

# **RDR Promotions Back at the 2300 Arena in Philadelphia with Jesse Hart against David Murray in Headline Bout on Saturday, December 11th**

PHILADELPHIA (December 1, 2021)—Two-time world title challenger Jesse Hart will be back in action on Saturday, December 11th at the 2300 Arena when he takes on David Murray in the eight round super middleweight main event.

The card is promoted by RDR Promotions.

Hart of Philadelphia has a record of 27-3 with 21 knockouts. The 32 year-old has twice battled for the super middleweight championship of the world only to fall just short to Gilberto Ramirez in fights that were decided by just a couple of points.

After a stellar amateur career, Hart turned professional on June 9, 2012 with a 1st round stoppage of Manuel Eastman in Las Vegas. That led to Hart winning his first 22 fights (20 by knockout), with victories over Tyrell Hendrix (10-2-2), Samuel Clarkson (10-2), Roberto Acevedo (8-2), Mike Jimenez (17-0), Andrew Hernandez (16-4-1), Alan Campa (16-2). Hart also has victories over Demond Nicholson (18-2), Mike Gavronksi (24-2-1) and Sullivan Barrera (22-2). Hart is coming.

Murray of Wilmington, Delaware, has a record of 10-2-1 with six knockouts.

Murray is an eight-year professional, and is riding a three-fight winning streak with his latest win being a six-round unanimous decision over Austin Marcum on February 29, 2020 in

Hockessin, Delaware.

A massive undercard features RDR Promotions fighters, Shyngus Khan Tazibay (9-0, 2 KOs) of Washington, DC takes on an opponent to be named in a six-round middleweight fight and lightweight Isaiah Johnson (3-0, 3 KOs) of Sicklerville, NJ against opponent to be named.

PHILADELPHIA (September 21, 2021)—It will be a battle of featherweight contenders when Donald Smith takes on Elijah Pierce in the eight-round featured bout of a great night of boxing on Saturday, October 9th at the 2300 Arena.

Chester, PA (December 28, 2020) – Undefeated bantamweight prospect Dylan Price kicks off the New Year in a headlining role as he rematches veteran Samuel Gutierrez in a six-round bout on Saturday, January 16th at Elevations Event Center (51 9th Street) in Chester, Pa.

The event is promoted by RDR Promotions. RDR Promotions is the only promotion to stage an event during the Covid-19 Shutdown. This will be the 3rd show promoted by RDR Promotions and 2nd during the Covid-19 Restriction Period. RDR ran a successful event on November 7th at The 2300 Arena in Philadelphia.

Price of Sicklerville, New Jersey. has a record of 11-0 with eight knockouts, and he took an eight-round unanimous decision over Gutierrez on July 27, 2019 in Baltimore, Maryland.

The 22 year-old is a four year professional who is coming off a 2nd round stoppage over Jose Rodriguez on November 7th in Philadelphia.

Gutierrez of Mexico has a record of 16-28-6 with six knockouts.

# Dawson, Price, Butt and Charles Register wins in Philadelphia

Philadelphia, PA (November 10, 2020) – This past Saturday night, boxing returned to Philadelphia after an eight-month shutdown due to the Coronavirus pandemic with a four-bout card promoted by RDR Promotions.

All Covid-19 protocols were followed as a limited, yet capacity crowd was on hand to witness the first card in the city since RDR Promotions staged a sold-out full capacity show eight months to the day.

In the main event, Mark Dawson Jr. remained undefeated with six-round unanimous decision over cross-town rival Vincent Floyd in a welterweight contest.

Dawson, who was making his 1st start in 20 months, showed no signs of ring-rust as he landed a some solid over hand lefts and right hooks against the tall southpaw Floyd.

Dawson, is managed by Split-T Management, won by scores of 60-54 twice and 59-55, to raise his mark to 7-0-1. Floyd falls to 4-10-1.

Daiyaan Butt of Philadelphia remained perfect with a four-round unanimous decision over Dieumerci Nzau.

Dylan Price remained undefeated with a 3rd round stoppage over Jose Rodriguez in their scheduled four-round bantamweight

# Teah Decisions Nzau in Philadelphia

The successful show, which was attended by many members of the boxing community as well as well as WWE superstars, was the inaugural card staged by RDR Promotions.

Teah of Philadelphia dropped Nzau in the opening frame with a hard right hand to the head. Teah never was challenged in the bout that saw him win by scores of 60-53 twice and 59-54.

Teah now has a record of 17-3-1. Nzau of Silver Spring, Maryland is now 11-12.

Brandon Robinson got off the deck in round two to comeback and stop Josue Obando in the same round of their scheduled six-round super middleweight bout.
