Vazquez Pounds Out Unanimous Decision over Argel in Philly

PHILADELPHIA (JULY 12, 2022)—Featherweight contender **Edward Vazquez** pounded out a eight-round unanimous over tough Jose Argel in the main event that topped a seven bout card at the 2300 Arena in Philadelphia.

The event was promoted by RDR Promotions.

Vazquez of Fort Worth, Texas was able to figure out Argel's come-forward style early in the contest as the Texan started slowing down Argel with body shots with both hands. Vazquez was equally effective with the uppercut. Argel continued to attempt to press but that was to his detriment as he ate shots to his flank and face from the pinpoint Vazquez.

Vazquez, 128.8 lbs won by scores of 80-72 on all cards to raise his mark to 12-1. Argel, 127.2 lbs of Carolina, Puerto Rico via Chile is now 8-3.
